- Medicare Card &/or Passport
- Credit or Bank Card
- Identification Card

2.) RENTAL HISTORY: including

- Four previous rental receipts (if direct deposit copy of your bank statement).
- References from previous landlord(s) or agent(s)
- A copy of the Lease Agreement
- Tenant Ledger- this can be obtained from your managing agent

If you do not have a rental history (i.e. your have previously owned your own home) please provide proof of ownership such as council rates.

3.) PROOF OF RESIDENTIAL ADDRESS:

Current motor vehicle registration papers.

4.) PROOF OF INCOME:

- Two previous payslips
- If you are self employed please include a copy of the business registration and Tax Returns from the last two years

- Rental Bond (the sum of four weeks rent)
- Two weeks/ One month rent

All monies may be paid either by Bank Cheque, Money Transfer or Direct Deposit.
